**RECITALS**

1. Article VII of the EMPLOYMENT REGULATIONS FOR THE CLASSIFIED SERVICE OF THE SAN DIEGO UNIFIED SCHOOL DISTRICT provides for the layoff and reemployment of classified employees not covered by a current collective bargaining agreement; and

2. The positions listed in Exhibit A to this resolution are not covered by a current collective bargaining unit; and

3. California Education Code Sections 45114, 45117, 45298 and 45308 govern the layoff and reemployment of members of the classified service; and

1. NOW, THEREFORE, due to lack of work or lack of funds, the Board of Education of the DISTRICT hereby finds that it is in the best interests of this School District that as of June 30, 2017, certain services now being provided by the DISTRICT be reduced or discontinued to the following extent:

2. BE IT FURTHER RESOLVED that as of June 30, 2017 the position listed in Exhibit "A" be reduced to the extent set forth therein.
